## EXECUTIVE ORDER NO. 2017-08-16A Series of 2017

RE-ORGANIZATION OF THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) OF BALAOAN, LA UNION AND CONSTITUTION OF THE COMPOSITIONS OF ITS SECTORAL COMMITTEES

WHEREAS, Republic Act 7160, otherwise known as the Local Government Code of 1991 provides that every Local Government Unit (LGU) shall have a comprehensive multisectoral development plan to be initiated by the Local Development Council (LDC) concerned and approved by its Sanggunian;

WHEREAS, for the purpose, the Development Council at the municipal level, shall assist the corresponding Sanggunian in setting the direction of economic and social development, and coordinating development efforts within its territorial jurisdiction;

WHEREAS, the LDC being the body mandated to prepare the multi-sectoral development plan of an LGU, it is critical to ensure that the LDC as well as its executive and sectoral committees, as providers of technical support and assistance are constituted and activated;

NOW THEREFORE, I, ATTY. ALELI U. CONCEPCION, Municipal Mayor, by virtue of the powers vested in me by law, hereby reorganize the Municipal Development Council (MDC) of the Municipality of Balaoan, La Union and to constitute composition of its executive and sectoral committees, as follows:

- 4. Formulate local investment incentives to promote the inflow and direction of private investment capital;

SECRETARY** – The Secretariat of the MDC shall be headed by the Municipal Planning and Development Coordinator, who shall be responsible for providing technical and administrative support, documentation or proceedings, preparation of reports and such other assistance as may be required in the discharge of its functions.

**Section 7. REPEALING CLAUSE** – This Executive Order supersedes previous Executive Orders issued for the purpose.

Section 8. EFFECTIVITY - This Executive Order shall take effect immediately.
