**RE-ORGANIZATION OF THE MUNICIPAL COUNCIL FOR THE PROTECTION OF CHILDREN
(MCPC) IN THE MUNICIPALITY OF BALAOAN, LA UNION**

WHEREAS, pursuant to DILG Memorandum Circular No. 2002-121 dated August 5, 2002, LGUs are encouraged to organize/re-organize their respective Local Council for the Protection of Children in the locality with the view of making the locality child-friendly;

WHEREAS, there is a need to re-organize said Body to undertake activities that shall promote child welfare and development in all barangays of this municipality;

WHEREAS, due to the organizational changes under the new administration, there is a need to reconstitute the existing Local Council for the Protection of Children in order to update the Council Membership and its Secretariat and clearly define their functions;

NOW THEREFORE, I, ATTY. ALELI U. CONCEPCION, Municipal Mayor of Balaoan, La Union, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 2. FUNCTIONS OF THE MCPC.

The MCPC shall discharge the following:

1. Prepare and update the situationer or current database on children as basis for local planning on children;
2. Prepare the municipal work and financial plan for children;
3. Monitor the four (4) gifts for children, namely: a.) Municipal/Barangay Development Plan for Children, b.) Local Investment Plan for Children, c.) Local Code for Children and d.) Local State of the Children Report;
4. Refer to agencies/NGOs those children in need of assistance/protection and follow up action taken;
5. Ensure and monitor the enforcement of laws/policies for the survival, development, protection and participation of children; and
6. Monitor and assess programs, projects and activities on children being undertaken by the LGU.

SECTION 3. SECRETARIAT

The Office of the Municipal Welfare and Development Officer shall provide Secretariat services to the MCPC.

SECTION 4. EFFECTIVITY

This Executive Order shall take effect immediately.
