- Help carry out the provisions of Executive Order No. 26, including the apprehension of violators and the institution of criminal proceedings for violations of the Executive Order, in accordance with relevant laws, rules and regulations and strictly observing due process.
- 2. Work closely with the Philippine National Police (PNP) in implementing the order including the apprehension of violators.
- 3. Advocate for the effective implementation of the program to ensure continuous awareness and support for the program.
