MUNICIPAL ORDINANCE NO. 03 S. 2020

ORDINANCE GOVERNING THE SALE, USE AND DISPOSITION OF BURIAL LOTS AT THE NEWLY DEVELOPED AREA OF THE MUNICIPAL CEMETERY OF THE MUNICIPALITY OF BALAOAN, LA UNION.

Section 1. TITLE. This ordinance shall be known as an, "ORDINANCE GOVERNING THE SALE, USE AND DISPOSITION OF BURIAL LOTS AT THE NEWLY DEVELOPED AREA OF THE MUNICIPAL CEMETERY OF THE MUNICIPALITY OF BALAOAN, LA UNION".

Section 2. SCOPE. This Ordinance shall cover all lots at the newly developed area of the Municipal Cemetery of the Municipality of Balaoan, La Union appearing in Annex "A", which shall form an integral part of this ordinance, including persons and entities purchasing burial lots thereat.

Section 3. DEFINITION TERMS. When used in this ordinance, the following terms shall mean:

- 1. Tombstone lot** – any burial lot in the newly developed area of the Municipal Cemetery of the Municipality of Balaoan with an area of 2.30 square meters purposely intended for tombstones or "pantheon".
- 2. Fence** – any structure or installation built or planted around a tombstone or "pantheon" serving as a perimeter enclosure in order to separate or distinguish it from nearby burial lots.
- 3. Roof** – any structure made of wood, concrete or other material purposely installed over a tombstone or "pantheon".

Section 4. GENERAL AND SPECIFIC PROVISIONS

4.1. Only residents of the Municipality of Balaoan can be allowed to purchase lots at the newly developed area of the Municipal Cemetery of the Municipality of Balaoan, La Union

4.2. Tombstone lots shall either be designated as inner or outer lots depending upon their location in Annex "A" of this ordinance.

4.2.1. Tombstone lots shall be priced as follows:

Outer lots: Ten Thousand Pesos (Php 10,000.00) per lot

Inner lots: Eight Thousand Pesos (Php 8,000.00) per lot

4.2.2. Any client or buyer of tombstone lots may only be allowed to purchase one (1) lot.

4.2.3 Only one (1) tombstone or "pantheon" may be allowed to be constructed in any of the tombstone lots, however, the client or buyer may have the option to construct an underground tomb to accommodate any dead relative provided that the total height of the construction shall not exceed a maximum height of 1.2 meters from the surface ground to the top.

4.2.4 No fence nor roof shall be built in the area for tombstone lots.


Section 5. IMPLEMENTATION. All constructions in the newly developed area of the Municipal Cemetery of the Municipality of Balaoan, La Union shall be coursed through the Office of the Municipal Engineer which shall supervise all constructions being undertaken.

Section 6. EFFECTIVITY. This ordinance shall take effect upon approval and upon compliance with the posting and publication requirements.


