**RESOLUTION APPROVING THE REALIGNMENT OF THE MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC) FUND OF CY 2020 IN THE AMOUNT OF TWO HUNDRED SEVENTY THOUSAND PESOS (P270,000.00) FOR THE DEVELOPMENT PROGRAMS, PROJECTS AND ACTIVITIES TO SUPPORT COVID-19 RESPONSE EFFORTS IN THE MUNICIPALITY OF BALAOAN, LA UNION.**

**WHEREAS**, presented for consideration is a letter from the Municipal Mayor requesting the body to pass a Resolution approving the realignment of the Municipal Anti-Drug Abuse Council (MADAC) Fund of CY 2020 in the amount of Two Hundred Seventy Thousand Pesos (P270,000.00) for the development programs, projects and activities to support COVID-19 response efforts of the Municipality of Balaoan, La Union;

**WHEREAS**, Republic Act (RA) No. 11469 otherwise known as Bayanihan to Heal As One Act which was approved last March 25, 2020 directs local government units (LGUs) to actively respond and cooperate in implementing policies issued by the National Government relative to COVID-19;

**WHEREAS**, the Department of the Interior and Local Government (DILG) issued Memorandum Circular No. 2020-079 setting Clarificatory Guidelines on the use of Peace and Order Council (POC) Funds for COVID-19 related programs, projects, services and activities (PPSAS);

**WHEREAS**, anti-drug programs are part of the municipality's Peace and Order and Public Safety (POPS) Plan in support of the national government's effort in fighting illegal drugs;

**WHEREAS**, the Municipality of Balaoan as a drug free municipality also promotes peace, order and public safety of its constituents;

**WHEREAS**, due to the threat of the Corona Virus Disease 2019 (COVID-19) the Municipality of Balaoan must render full assistance and mobilize the necessary resources to undertake appropriate aid to its constituents;

**WHEREAS**, in order for the Municipal Government to provide more relief assistance to its constituents during these difficult times, the Municipal Peace and Order Council (MPOC) and the Municipal Anti-Drug Abuse Council (MADAC) have decided to realign the remaining MADAC Fund amounting to Two Hundred Seventy Thousand Pesos (P270,000.00) into development programs, projects and activities to support COVID-19 response efforts of the municipality through MPOC-MADAC Joint Resolution No. 01, Series of 2020 dated September 29, 2020;

**WHEREAS**, the realigned fund will be used to purchase food packs to be distributed to the needy families in the municipality, taken from the list of the Municipal Social Welfare and Development Office database of indigents;

**WHEREAS**, the Sangguniang Bayan needs to approve the proposed realignment in order to abide by the prescribed accounting and auditing rules and regulations and other applicable laws;


**NOW, THEREFORE**, on motion duly seconded, Be it:
