RESOLUTION NO. 135 S. 2020

RESOLUTION AUTHORIZING ATTY. ALELI U. CONCEPCION, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF BALAOAN, LA UNION TO DONATE ONE (1) UNIT OF PORTABLE POWER GENERATOR 5KVA WITH POWER CABLE TO EACH BARANGAY OF BALAOAN, LA UNION.

WHEREAS, presented for consideration is a letter from the Municipal Mayor requesting the body to pass a Resolution authorizing her, for and in behalf of the Municipality of Balaoan, La Union to donate one (1) unit of Portable Power Generator 5KVA with power cable to each barangay of Balaoan, La Union;

WHEREAS, forty (40) Portable Power Generator 5KVA with power cables were purchased by the Municipal Government from the five percent (5%) Disaster Risk Reduction and Management (DRRM) Funds 2020;

WHEREAS, the donation of Portable Power Generator 5KVA with power cable is beneficial to the thirty six (36) barangays of the municipality during power outage and emergency cases where electricity is needed in doing transactions and serving their constituents:

WHÈREAS, the provision of necessary assistance to its constituents and all the barangays in the municipality is one of the main concerns of the Municipal Government especially during emergency cases like power outage so that public service will be uninterrupted;

WHEREAS, a Deed of Donation between the Municipality of Balaoan, La Union represented by the Municipal Mayor and the thirty six (36) barangays of the municipality is necessary in order to officially effect the transfer of said Portable Power

Generator 5KVA with power cable and document their ownership to abide by the prescribed accounting and auditing rules and regulations and other applicable laws;
